

School Policies

School Policies should be signed by every parent in person!!!!

Your signature indicates your agreement with our rules as follows: Payment and Attendance Commitment:

Tuition is due at the first day of each Session. Invoice with the amount due is emailed in 1-3 days before the Session starts.

Tuition is not prorated because of a child's absences.

Some months may be prorated due to the School scheduling changes. If a class in which tuition would normally be due is cancelled because of snow days or other school cancellations, the tuition will be due at the following class date.

Students will automatically be moved to the next session

Once a session has started you are responsible for the entire 4 week payment for all registered classes. You are responsible for all charges incurred. No refunds will be given.

To cancel your registration or change schedule you must call, email or write us a note and it will be changed from the next session.

Tuition does not include all materials used in the classes: We charge extra fee for the Art Class Materials. You should buy books for the Russian Language Class.

If tuition has not been received by the day of the second class each Session, a \$10 late fee will be added to your invoice. To avoid late fees, please make sure that you pay at the first day of each Session.

If tuition has not been received at the first class of next Session a child will be removed from the program and his space can be occupied by the next student on the waiting list.

There is a \$36 administration charge on all NSF checks.

You can make you payment online with credit/ debit card or PayPal account or pay at the School with check or cash.

Discounts:

School offers a special hourly discount system

Families who have more than one child can cumulative their hours and increase the discount.

School offers discount for students and their parents for all School Events.

School Concerts and Performances:

The student(s) may perform in concerts, performances if s/he is attending classes, paying for the classes and is considered by the instructor to be participating in his program (Depends on quantity of missed classes).

Class Schedule Changes:

You will receive email indicating any class schedule changes necessitated by school closures.

Price for the cancelled Class will be deducted from the next session Invoice.

Behavior:

A student may be removed from classes if his/her behavior disrupts the class. If your child cannot control their behavior, we will contact you and require you to pick up your child immediately.

There is no refund or credit for a child removed from the program for behavioral reasons.

Classes:

Classes may have up to 12 students with 1 instructor.

.Classes which have 4 or fewer students may be closed or combined with other age group..

Please, be punctual when dropping off and picking up children.

If a class is full, you may choose to be placed on a waiting list.
